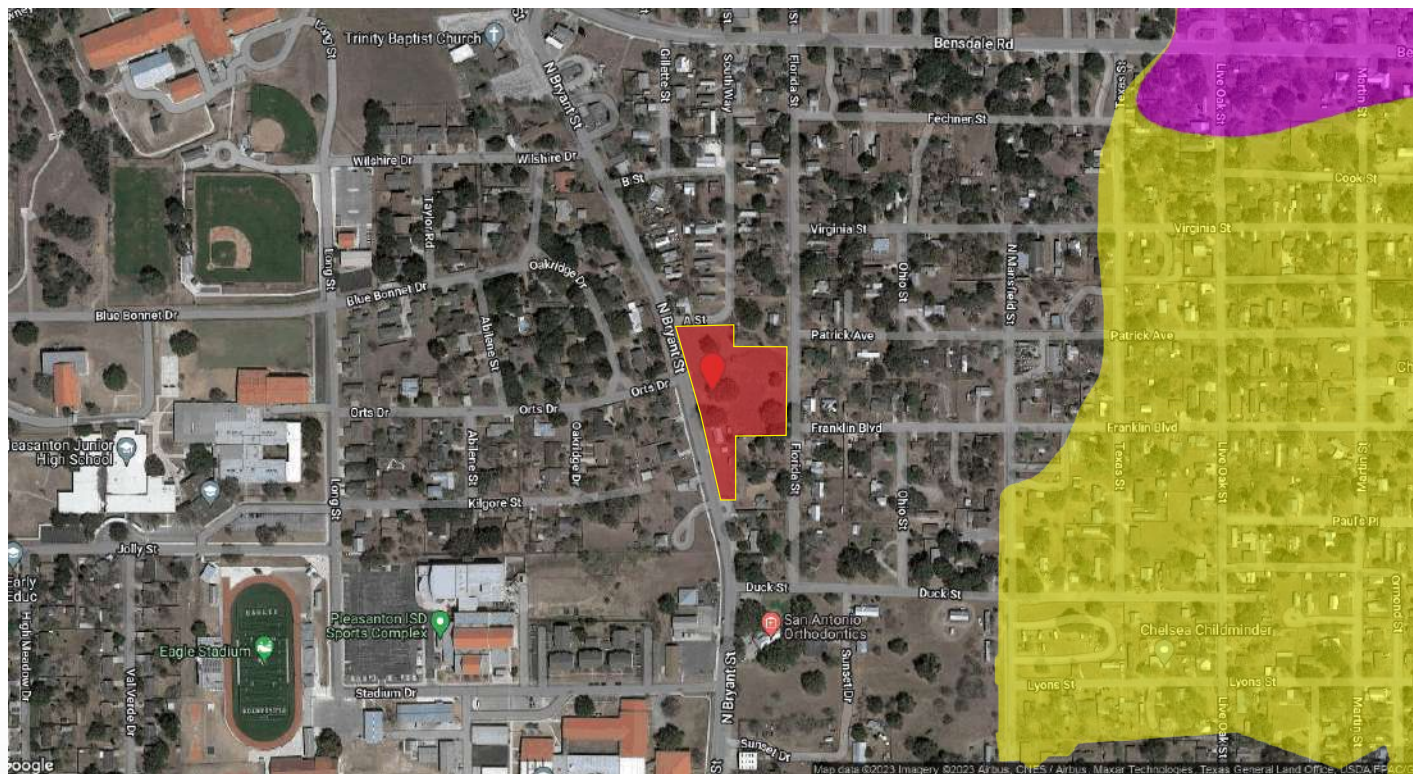

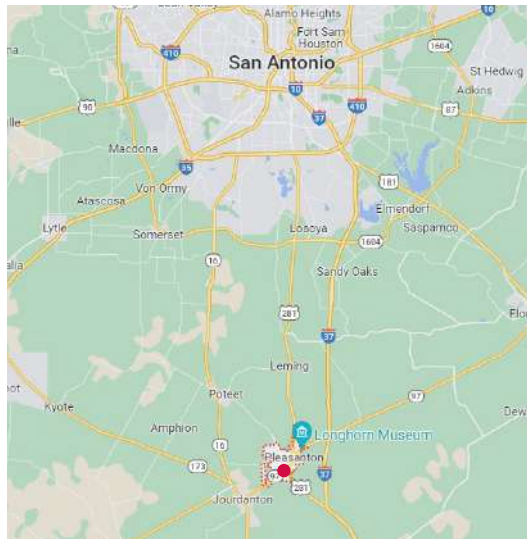
AERIAL MAP

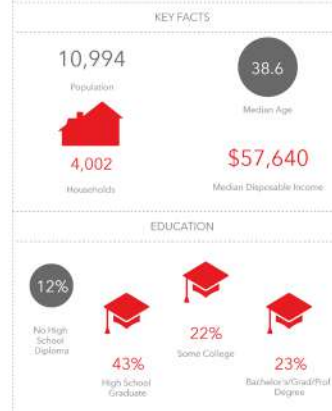
