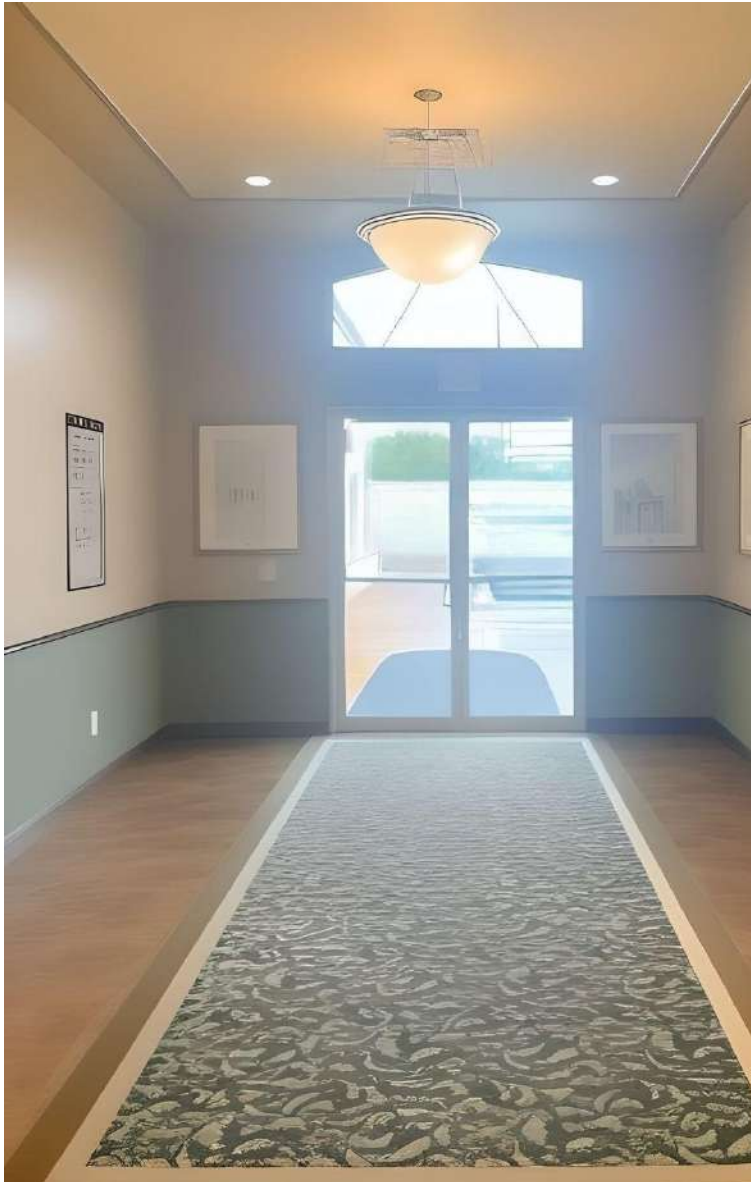

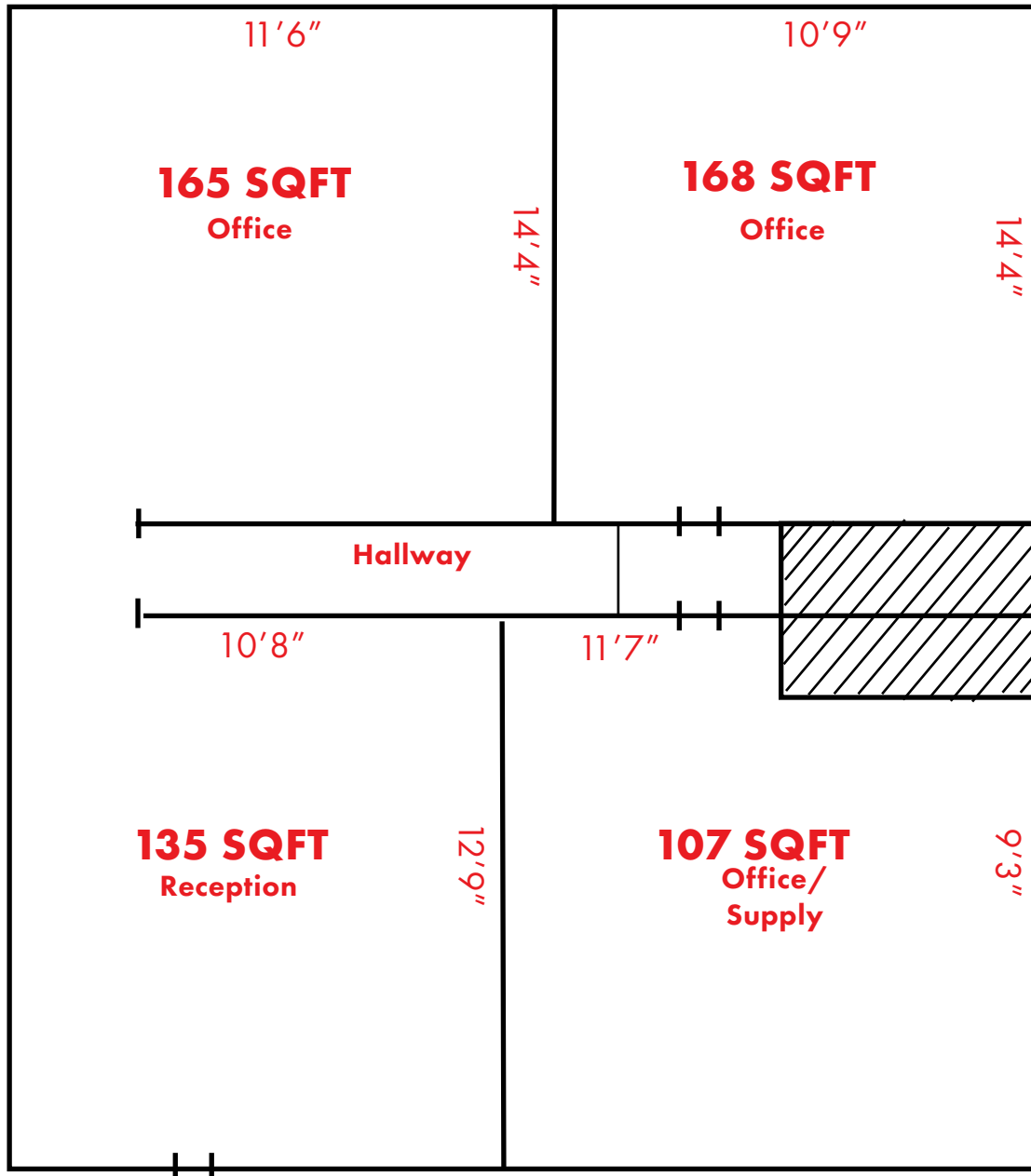

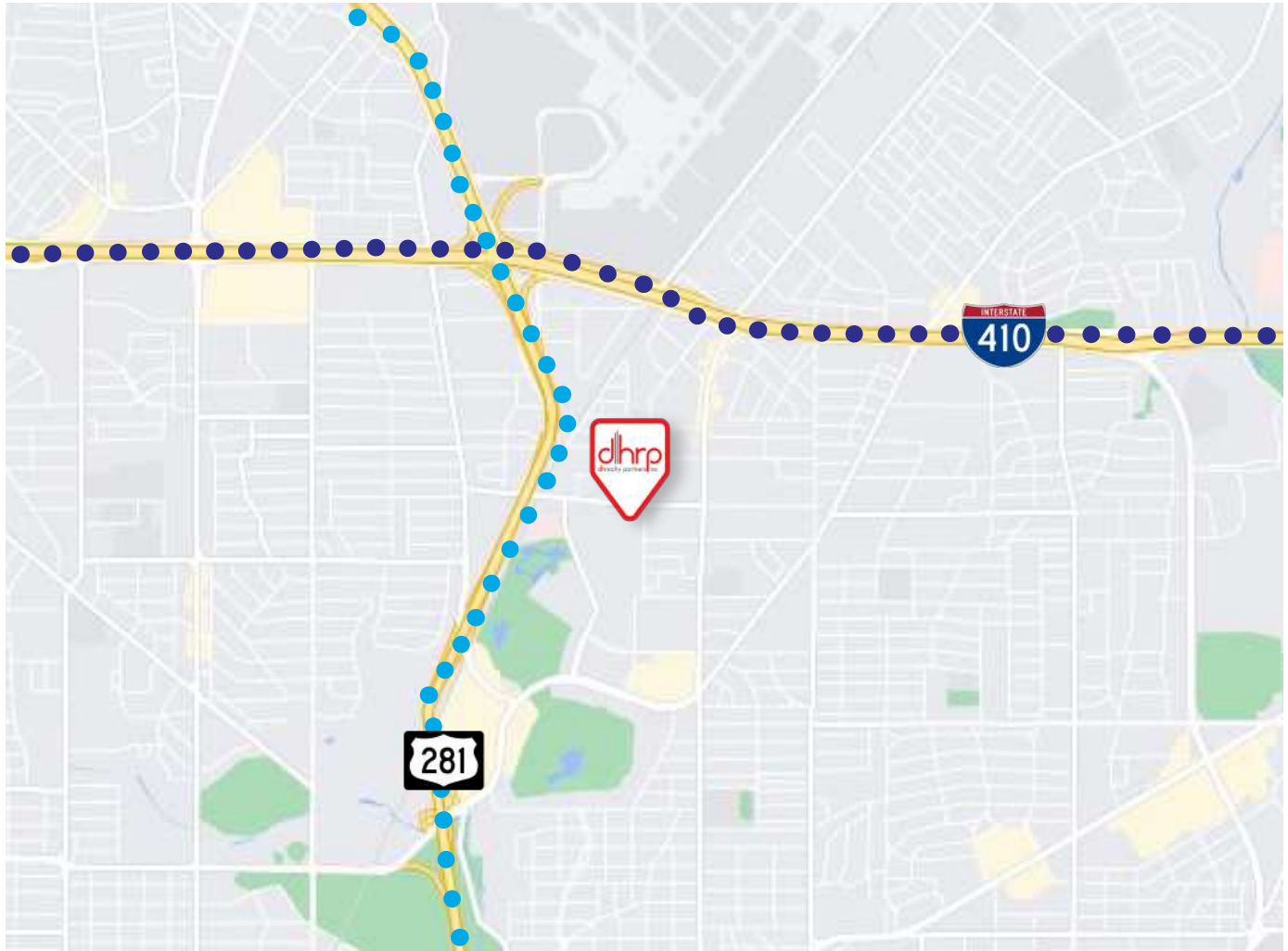

Information About Brokerage Services
