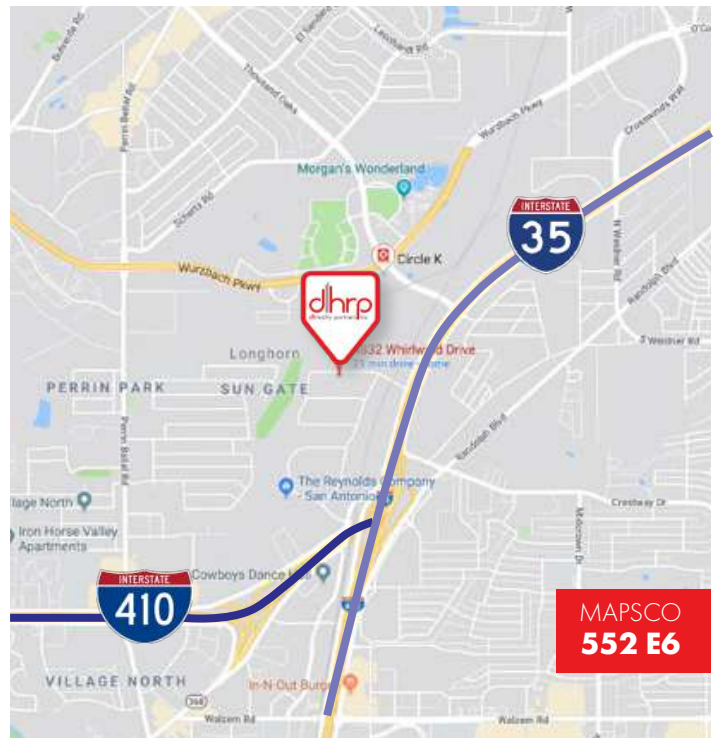

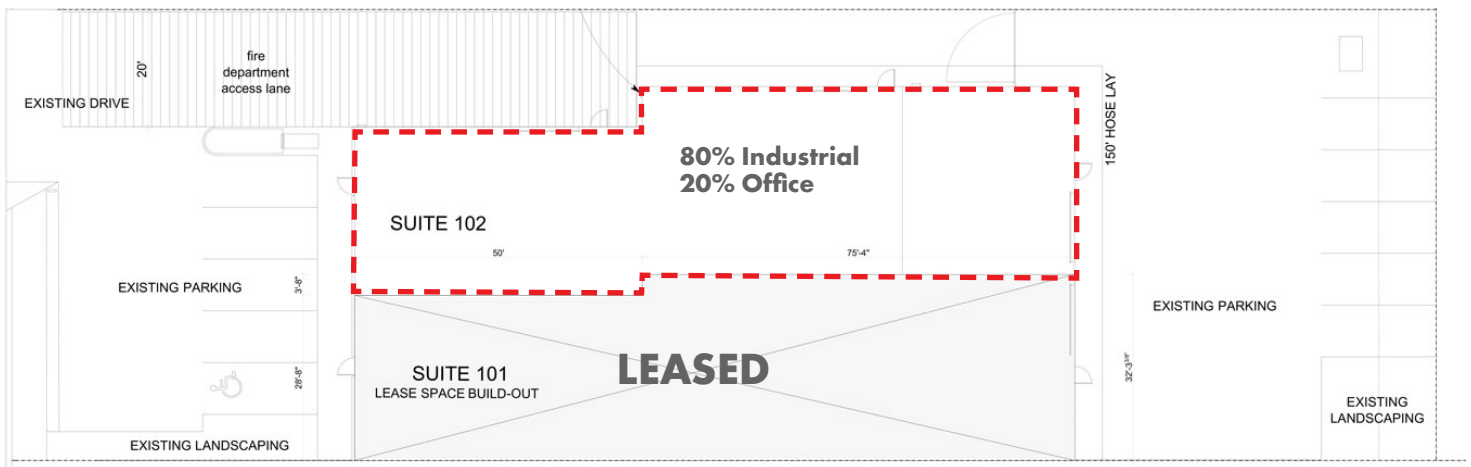

**SITE PLAN**

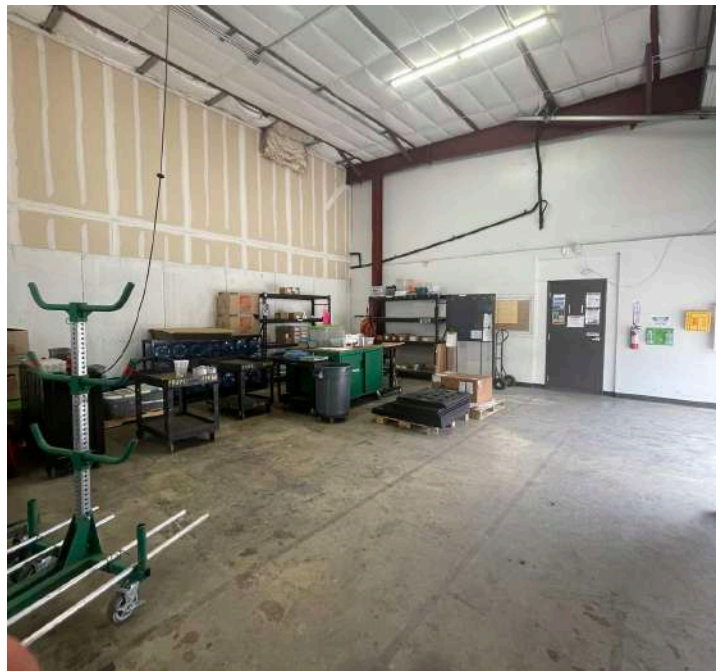
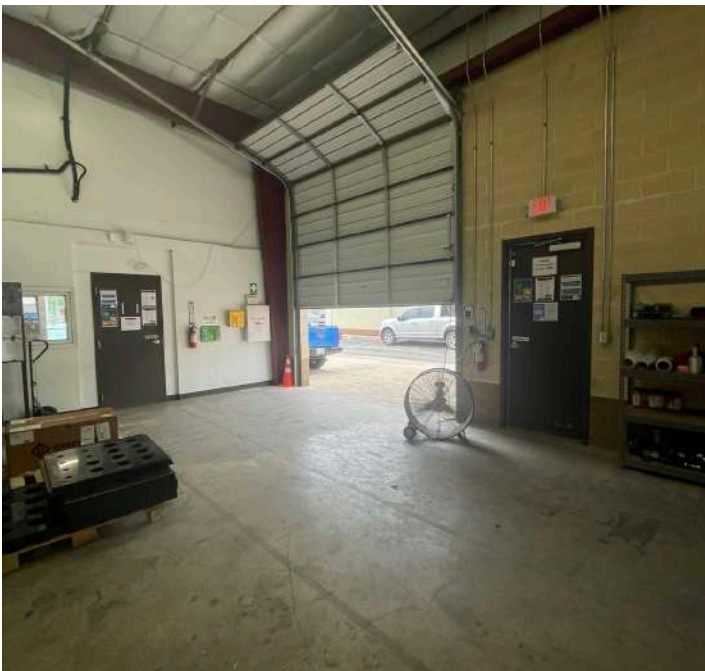

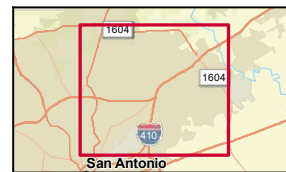
