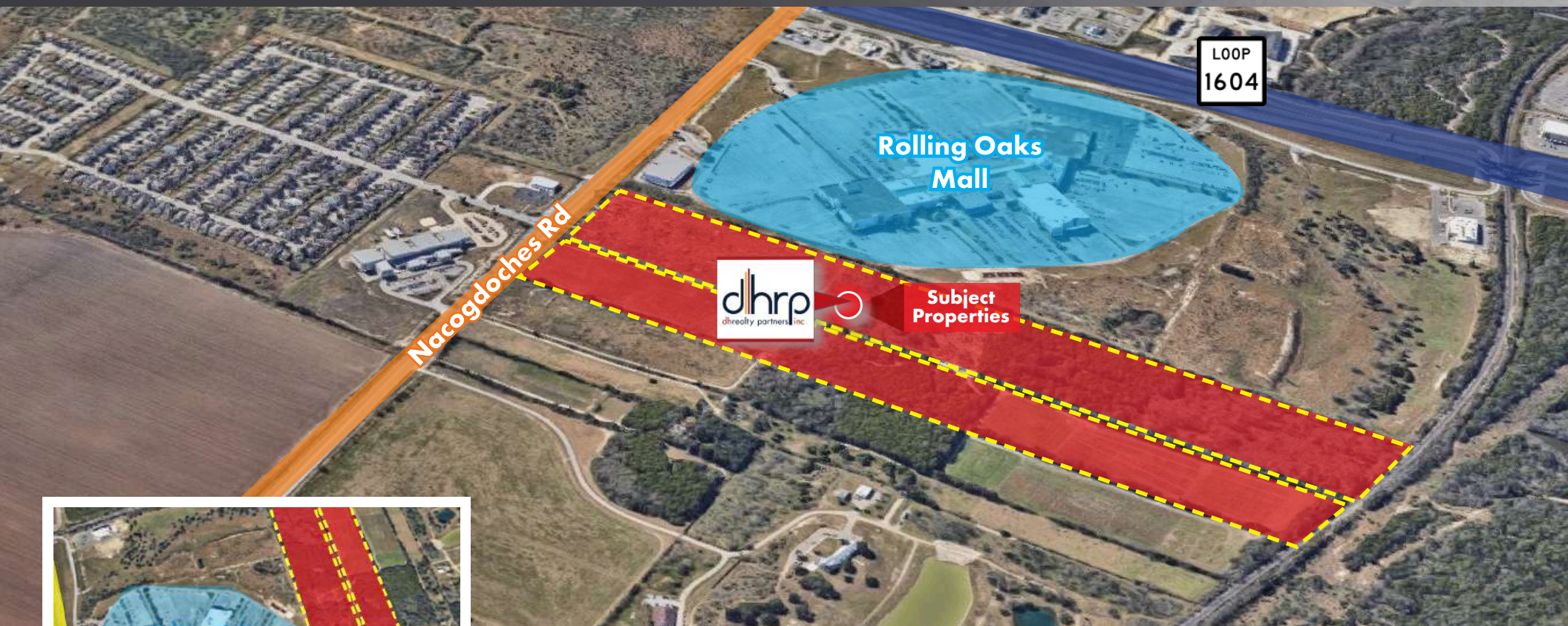

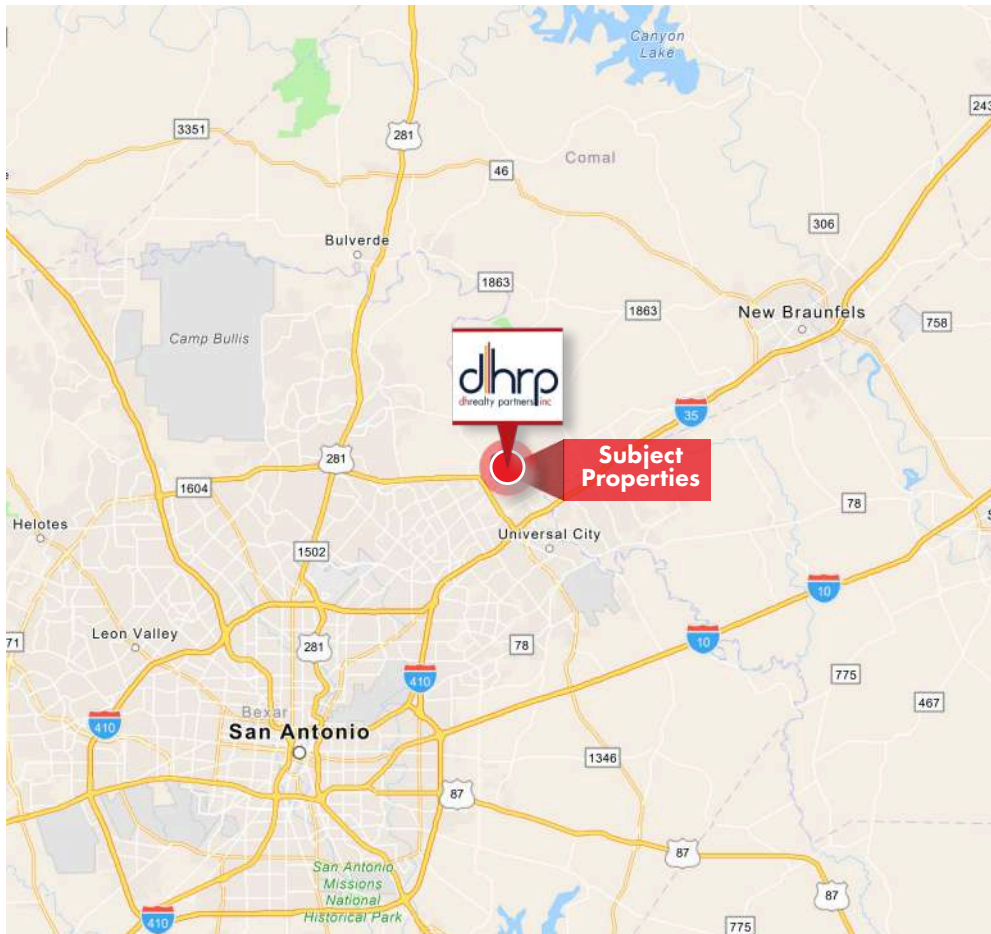

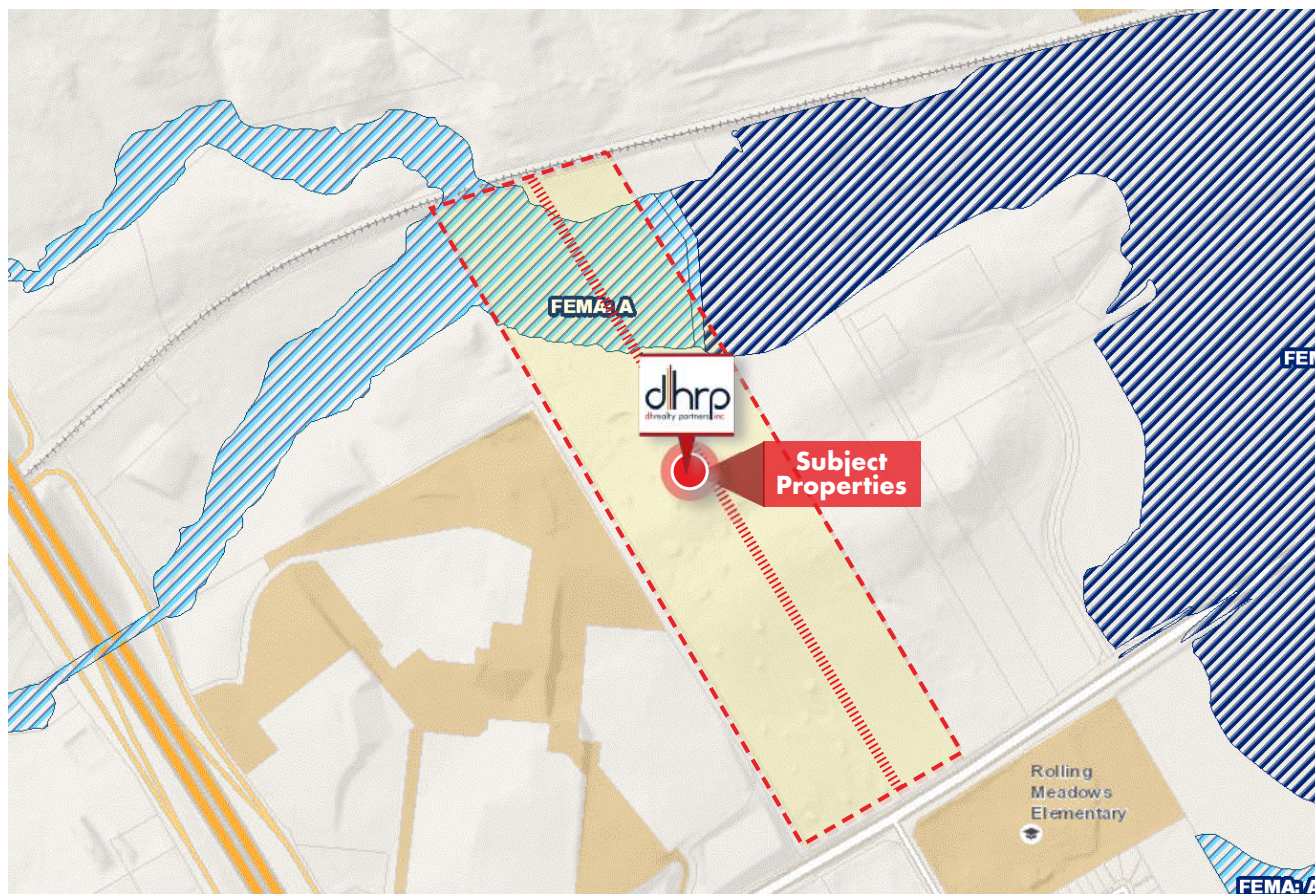

FLOOD MAP



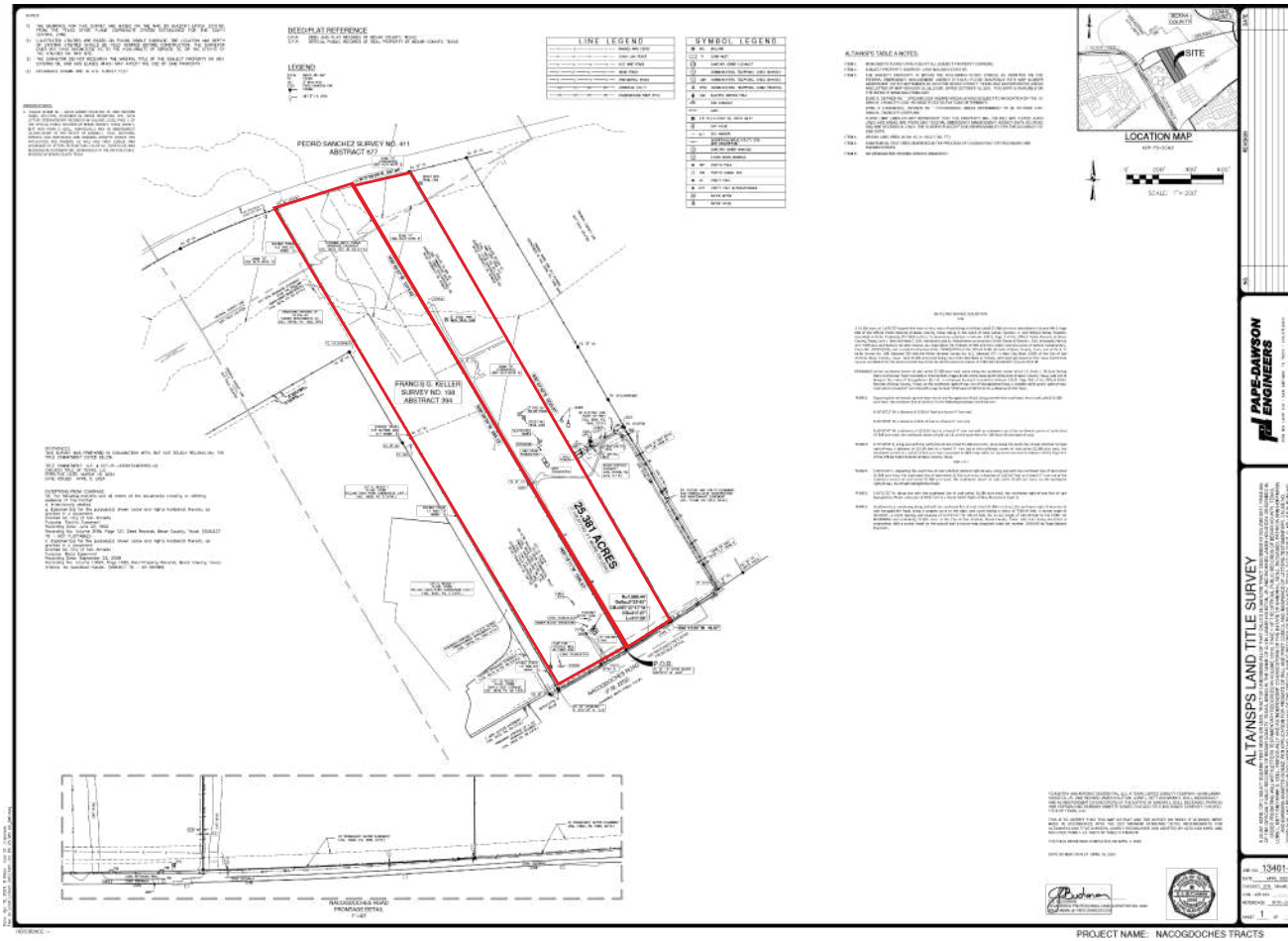

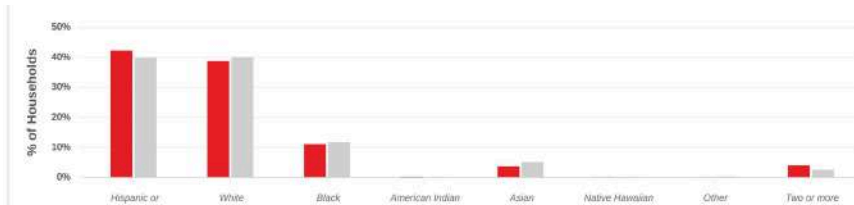
