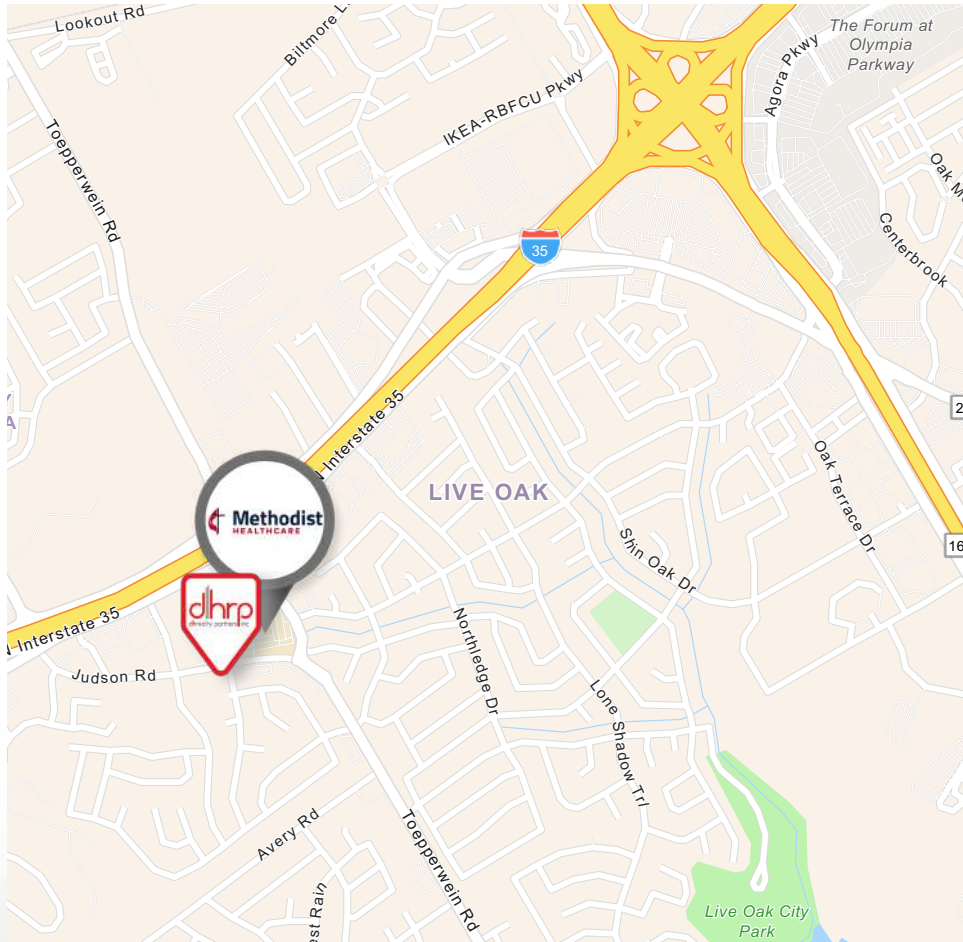

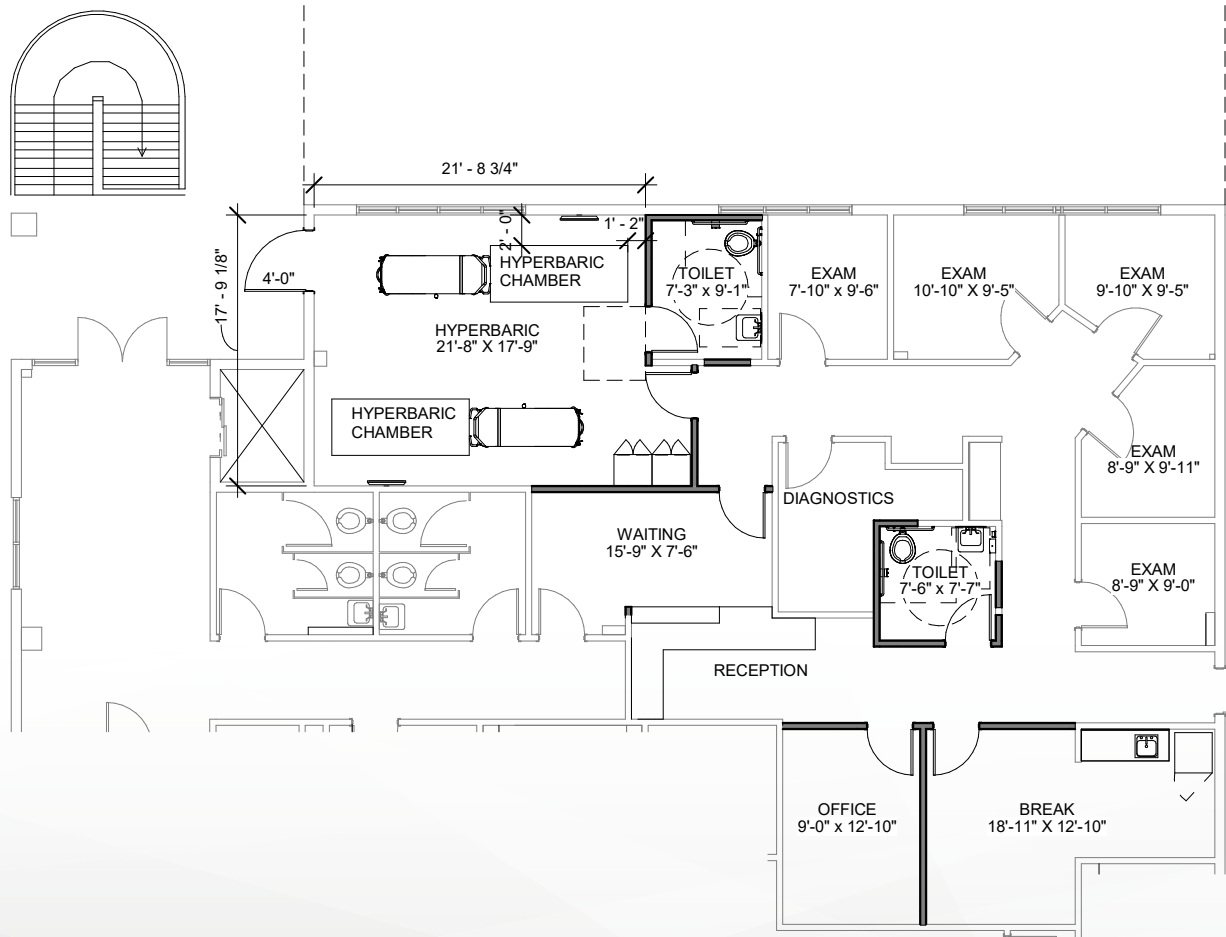

### SUITE 102 FLOOR PLAN



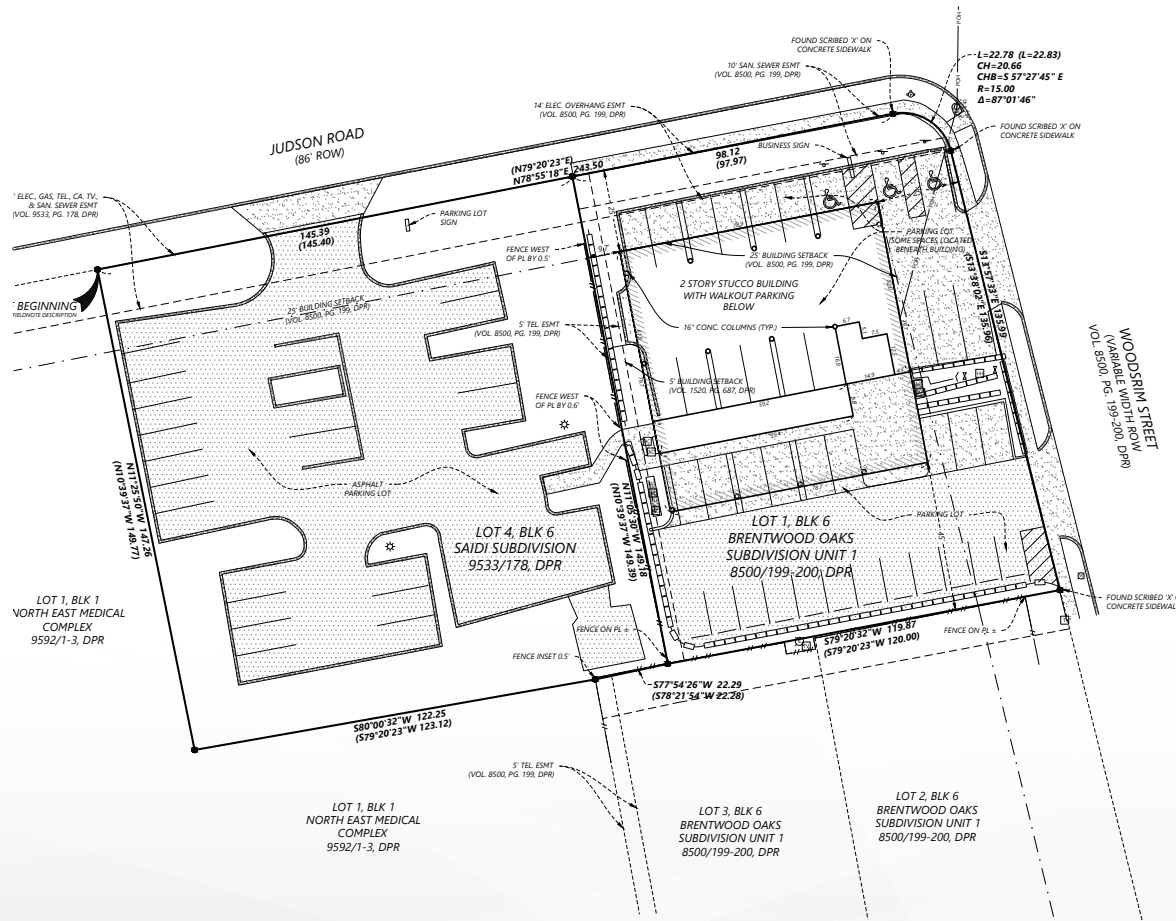

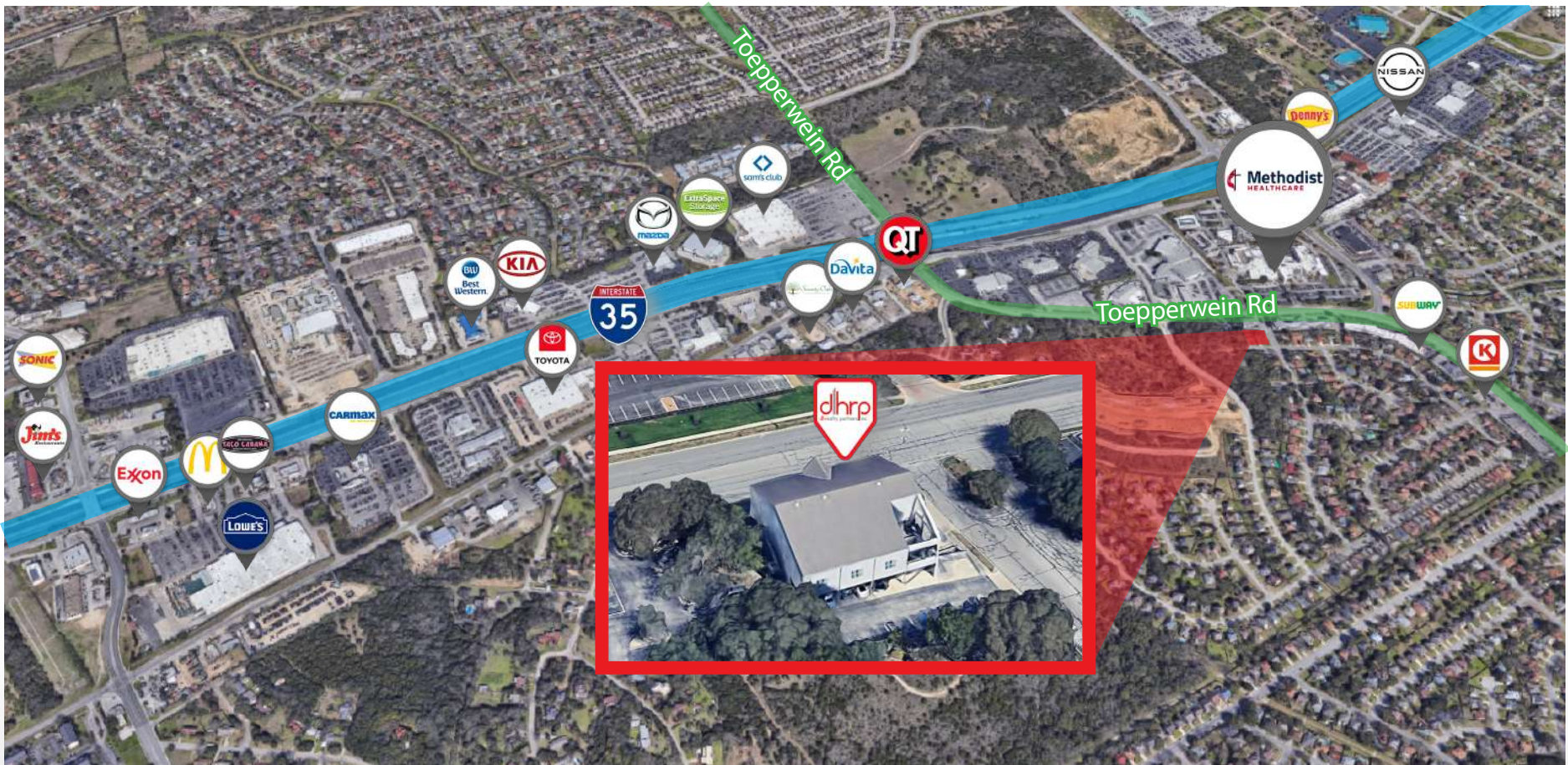
