PLAT MAP

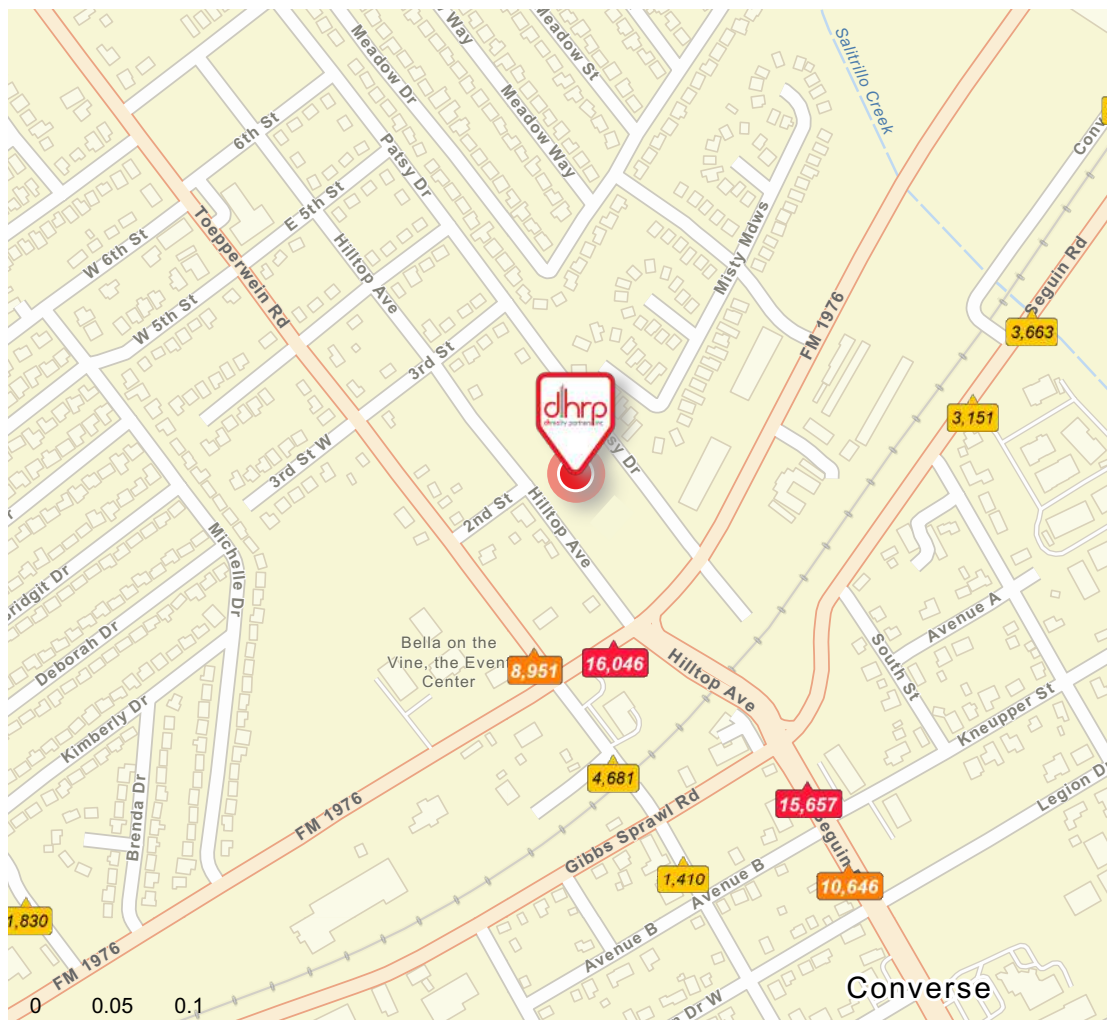
